**responding to a complaint: ohio - dinsmore** - answer within 14 days after notice of the court's action (ohio civ. r. 12(a)). serving an answer or other response if the court denies the motion to strike, the defendant(s) must serve their answer within 14 days after notice of the court's action (ohio civ. r. 12(a)). **how to respond to a complaint/motion for dismissal** - appropriate grounds (reasons) exist, he or she may make a motion to dismiss the complaint; motion must be made in a timely fashion (within the same time frame for service of an answer) or the defendant will be in default. a motion is an application to the court for a specific court order

**instructions to answer a complaint - lawhelpnc** - you must answer the complaint and file it at the office of the clerk of court within 30 days from the date you personally received the complaint or if received by registered mail, the date when you signed for the complaint. if you cannot respond within that time you must request additional time to answer. if you have to request additional time ... **100 ways to answer the question "how are you?"** - 18. eh,!you!win!some!you!lose! some. it takes a lot of patience to answer "how are you" when you feel like crap. that's why we've included some responses that turn the question around to the asker, which keeps the conversation light and positive—and takes pressure off of you. sometimes we can't be 100% honest. but we can respond ... **rule 3:1. scope. - judiciary of virginia** - or counts addressed therein. if a defendant files no other pleading than the answer, it shall be filed within said time. an answer shall respond to the paragraphs of the complaint. a general denial of the entire complaint or plea of the general issue shall not be permitted. (b) response after demurrer, plea or motion. **file a written response with the court answering your ...** - for most types of lawsuits, the law requires you to file a written response with the court within 30 calendar days after you are served. (code of civil procedure (ccp) § 412.20). if the 30 th day falls on a weekend or court holiday, you have until the end of the next business day to file your response. (ccp §§ 10, 12, 12a) **civil summons and complaint - pima county courthouse** - summons and complaint (or thirty (30) days if you were served out-of-state.) if you do not file an answer within this time, the plaintiff can ask the court to enter a "default" and a "default judgment" against you. your answer must state your defenses to the lawsuit. answer forms are available at the courthouse, and on the self-service **how to file an answer to a civil complaint for breach of ...** - you can defend yourself by filing an answer to the lawsuit in court. special forms are used, which you can get from the court. you must file an answer within 30 days of the date you are personally served with the summons and complaint. **tennessee rules of civil procedure rule 12** - against such party shall serve an answer thereto within thirty (30) days after the service upon him or her. the plaintiff shall serve a reply to a counterclaim in the answer within thirty (30) days after service of the answer, or, if a reply is ordered by the court, within thirty (30) days after service of the order, unless the order **civil answer - maricopa county justice courts** - an answer is the defendant's response to the plaintiff's allegations as stated in the complaint. an answer must be filed within twenty (20) calendar days from the date you were served with the civil summons and complaint. if the complaint was served outside of arizona, the time to answer time is thirty (30) calendar days.
